Recall Summary

Name of Product: Realspace® Magellan Performance-Electric Height-Adjustable Desk

Hazard: The control box has an electrical irregularity resulting in reverse polarity, which may pose a shock hazard.

Remedy: Consumers should immediately stop using the recalled desk and contact Office Depot to receive a free replacement control box with installation instructions. Office Depot is notifying purchasers directly.
